I have been informed that after entering the Federal Republic of Germany, a savings account with a balance of 10.332 must be presented to the responsible aliens authority in order to apply for a residence permit. In addition, this account must bear the following notice: only 1/12 of the amount may be withdrawn from this account each month.

I have also been informed that I am required to carry the above-mentioned sum in cash while entering the territory of the Federal Republic of Germany. I will be turned back at the border of the Schengen treaty area should I not be able to present the sum of 10.332€ upon entry.
